## Health and Safety Plan Requirements

- Continue to use the same template for the 2022-2023 school year.
- Reminder: Under ESSER requirements, LEAs must still review or update their Health and Safety Plan every six months up through September 30, 2024.
- Updated plans must be posted on your website, but you do not need to submit them to PDE.

## LEA Mandated and District Expectations

- Report positive cases of COVID-19 to DOH.
  - The district will continue to provide a dashboard on the website of cases.
  - In alignment with requirements in Title 28 Pa. Code Chapter 27 (relating to communicable and noncommunicable diseases), schools must report positive cases of COVID-19 to DOH. To meet the reporting requirement, schools should continue to submit aggregate case numbers to DOH on a weekly basis using a short survey on PDE's [Future Ready Comprehensive Planning Portal \(FRCPP\)](#). The survey should be submitted by 5:00 PM on Fridays.
  - If a school does not have any new cases within the reporting period, a survey does not need to be submitted.
  - This requirement will be effective August 19. (Survey should be live August 16, but the first reporting date is August 19)

# HEALTH AND SAFETY PLAN ADDENDUM CONTINUED



**The School District of the City of York as per the CDC is:**

- No longer recommending quarantine following exposure if asymptomatic **IRRESPECTIVE OF VACCINATION STATUS**
- No longer recommending differences in timing and other handling of exposure/illness depending on vaccination status
- No longer recommending contact tracing outside of healthcare and high-risk congregate settings

  - Get tested at least 5 full days after your last exposure
  - Test even if you don't develop symptoms
  - If you have already had COVID-19 within the past 90 days, see [specific testing recommendations](#)

# FACILITIES CLEANING, SANITIZING, DISINFECTING & VENTILATION

- The SDCY maintenance and custodial staff will implement proper disinfection procedures for cleaning classrooms, offices, and common areas after hours and during the school day as needed.
  - The staff, faculty and administration will be provided disinfection supplies to be used in classrooms and offices during the school day.
  - High traffic areas, including restrooms, handrails, and hallways, will be cleaned as needed during the course of the day.

# SOCIAL DISTANCING AND OTHER SAFETY



## PROTOCOLS

---

- The district will promote social distancing and continue to post signage.
  - Students are strongly encouraged to bring a water bottle to hydrate; there will be no use of water fountains, the district will provide hydration opportunities where needed.
  - Field trips will continue to be discontinued temporarily yet exceptions will be may be made for district partnerships. They must go through the approval process at administration in enough time for approval or denial.
  - School-wide assemblies will be permitted on a case by case basis.
  - The district will continue to promote virtual meetings when possible.
  - Temperature check detectors are installed but are not mandatory for building entry of staff, visitors and students.
